BOARD PRESIDENT

Like most organizations, this year challenged us to think about our services in new ways. We had to adjust staffing and services to meet the changing need. We had to develop new procedures, create new policies and some of the team had to move to working from home.

Shelter services, counseling, and legal advocacy services were able to be modified and continue. Other services like child visitation and sexual assault advocacy were more profoundly affected. 2020 at a Glance

EXECUTIVE DIRECTOR

Nearly five months into the 2020 fiscal year, a pandemic changed our world requiring AWARE, Inc. to adapt its services to survivors of domestic violence and sexual assault.

Immediate health and safety measures were put into place to safeguard against the spread of the virus. The pandemic set into motion an increased need for technology upgrades and the need to modify our infrastructure to support remote services for survivors and access for employees.

The pandemic forced us to question what safety meant for survivors who were now balancing health risks, with job security, potential homelessness, and physical safety. We witnessed a decrease in advocacy requests from Henry Ford Allegiance Health for sexual assault survivors seeking emergency medical care. Virtual visits for families posed additional safety risks and were impractical given the age of most children being seen at the visitation center.

We knew that the crimes of domestic violence and sexual assault had not decreased. Our counselors and legal advocates experienced increased requests for emotional support and relief through Personal Protection Orders. Survivors disclosed an increase in violence being used against them.

In 2020, the agency had to redefine advocacy and reevaluate its efforts to ensure survivors' access to services. The pandemic compelled us to reflect, adapt, assess, and adjust how we address safety and use our resources to help survivors gain independence.

Thank you, friends, for continuing to support our mission and our agency as we meet the needs of survivors during these challenging times.

Program Services

RESIDENTIAL SERVICES

Emergency shelter services are the cornerstone of AWARE, Inc. In 2020, 4,491 nights of shelter were provided to 180 adults and 153 children. That is an average of 25 nights per family. Despite having to reduce occupancy mid-year due to the pandemic, we sheltered more people than the previous year. 24-hour crisis line calls totaled 772.

FLEXIBLE FUNDING ASSISTANCE

Flexible funding assistance provides low-barrier, one-time emergency funds for expenses related to housing, employment, or other expenses to further safety and self-sufficiency. In 2020, 15 survivors received financial assistance to pay for delinquent utilities, rent, security deposits, transportation costs, relocation expenses, clothing, household items, home maintenance and repairs, and the cost for process service of civil protection orders.

NONRESIDENTIAL SERVICES

128 survivors of domestic and sexual violence received crisis support through individual counseling services, and support groups.

199 adults and children seeking remedies through the courts received help with filing a Personal Protection Order, information about the legal process, victim notification, safety planning and referrals.

The sexual assault response team provided support and advocacy to 89 survivors, 46 of whom received advocacy and support during a medical forensic exam.

The Jackson County Family Visitation Center provided 52 monitored visits and seven supervised exchanges for 59 families.

AWARE, Inc. provided training and distributed information to area schools, colleges, community centers, service groups, social service agencies, churches and during community events. In 2020, we reached over 260 adults and students through 10 presentations and events.




