2021 in Review

Board President

2021 was a great year due to your support! As we share our work for 2021, thank you, thank you for all you do to support our mission. We would not have been successful without your support.

Like most organizations, we were to be challenged with the delivery services due to the COVID-19 pandemic. The pandemic has of course, shifted our work for a second year. However, we prevailed. During the FY21 we were able to serve 852 adults and children, and provide education and training to 176 community members.

In meeting the challenges that the COVID-19 pandemic posed, our staff shifted the way they worked. We continued to provide shelter services by following CDC guidelines and having a small number of residents in the shelter. We successfully worked with local hotels to provide additional housing to the families and individuals we served. I am thankful for the hard work of our staff and appreciate that they continued to provide the services even in the face of COVID-19.

While staff shifted their work, our partners provided significant support. 2021 in Review

Executive Director

The pandemic challenged everyone. Yet, our shelter employees showed up every day, putting aside their personal fears and risks to their own health. Our greatest asset is our staff who without hesitation, changed course, adapted and responded to survivor needs with care and empathy.

The agency had to get back to its core roots of 'survivor-defined' advocacy and creatively use our resources to meet emergency needs, facilitate safety, housing, employment and assist with costs that further self-determination. We reduced barriers to justice by covering the cost for process service of Personal Protection Orders. We assisted survivors with the expenses necessary to start over, moving them from homes that were unsafe to homes free from violence. We covered the costs for title transfers, plates and fees for donated vehicles. We provided temporary shelter in local hotels to ensure safe distancing in the emergency shelter.

As we move to in-person services, we continue using any accommodations that reduced barriers to survivors. We will be nimble and respond accordingly as COVID positivity rates fluctuate to both keep survivors and employees safe.

Finally, we sadly said 'goodbye' to two long-time employees of AWARE, Inc. at the end of this fiscal year. Sue Griwatsch, legal advocate, departed after 30 years with the agency. Karis Tripp, nonresidential services manager, departed after 12 years. We wish you both the best and thank you for your service to our mission.

Program Services

Residential Services

Emergency shelter services are the cornerstone of AWARE, Inc. In 2021, 3,275 nights of shelter were provided to 129 adults and 74 children. That is an average of 32 nights per family. 24-hour crisis line calls totaled 826.

Flexible funding assistance

50 survivors received financial assistance to pay for delinquent utilities, rent, security deposits, transportation costs, relocation expenses, clothing, food, household items, home maintenance and repairs, and the cost for process service of civil protection orders.

Nonresidential services

116 survivors of domestic and sexual violence received crisis support through individual counseling services, and 95 survivors through support groups.

204 adults and children seeking remedies through the courts received help with filing a Personal Protection Order, information about the legal process, victim notification, safety planning and referrals.

The sexual assault response team provided support and advocacy to 89 survivors, 30 of whom received advocacy and support during a medical forensic exam.

The Jackson County Family Visitation Center provided 212 monitored visits to 95 families (duplicated count).

AWARE, Inc. reached 176 individuals through community awareness and training on domestic violence, sexual assault, and its services.

collaboration

After 10 years of providing supervised visitation services through an agreement with Jackson County, the AWARE, Inc. Board of Directors made the difficult decision to cease operations of the supervised visitation center effective June 30, 2021, to coincide with the end of the contract period extended by the U.S. Department of Justice, Office of Violence Against Women.

Over the last five years, AWARE, Inc. has focused efforts on stabilizing its financial position and strengthening core services. Due to the unpredictable nature of the OVW grant and being that it is the sole source of funding for the visitation center, continuing these services places an undue financial burden on the agency.

AWARE, Inc. believe these services have been valuable to families struggling to co-parent post-separation and where domestic violence has been part of their histories. We also value our partnership with Jackson County and are willing to explore alternative options moving forward.

Thank you, to Jackson County, for the trust you have put into AWARE, Inc. to implement these services over the last ten years.



