Letter from the AWARE Executive Director

As we begin winding down COVID emergency measures, AWARE is reflecting on how the pandemic altered survivor needs and services. Emergency shelter continues to be a priority. Alternative options, such as shelter off-site through hotels is also an option. Bypassing shelter altogether was just as important. During the pandemic, we helped survivors with rental assistance, moving expenses, or barriers to housing, such as delinquent utilities to facilitate access to new homes.

Access to court systems and relief, such as Personal Protection Orders became extremely important during the pandemic. Our legal advocacy team were steadfast in their response during times when the courthouse was closed to the public. Our team showed up every day and provided access to survivors by text, e-mail, telephone, or by meeting off-site.

Counseling services were essential. Counselors reported seeing former clients return and an increase in new clients. Through the use of telehealth services, crisis counseling remained steadily available. Telehealth reduced barriers overall for survivors seeking support by reducing transportation and childcare needs.

In June 2022, we safely increased occupancy to 100%. But what we learned while operating with reduced occupancy, is the important of privacy. The overall shelter environment was calmer, less stressful and more conducive to healing.

As we look ahead, we will continue to prioritize survivor access to resources that meaningfully address their needs.

Program Services

Residential Services

In 2022, 145 adults and 133 number of children sought emergency shelter. 3,998 nights of shelter were provided, an average of 28 nights per family. 987 number of crisis calls were received by our advocacy team.

Flexible Funding Assistance

Flexible funding is low barrier financial assistance for expenses further survivor self-determination or impede access to safety. In 2022, 68 requests were met. Assistance included covering the costs for delinquent utilities, rent, security deposits, transportation costs, gas cards, household items, clothing, food, and the cost of process service of civil protection orders.

Nonresidential Services

Nonresidential services include counseling, legal advocacy, and sexual assault crisis response. In 2022, 102 survivors of domestic and sexual violence received counseling services. Another 165 adults seeking remedies through the courts received assistance with filing Personal Protection Orders, court accompaniment, victim notification, safety planning and referrals. Our sexual assault response team provided advocacy and support to 25 survivors, nine (9) of whom sought a medical forensic exam.




